II. MINUTES FROM APRIL 28, 2019 CONGREGATIONAL MEETING

- The Moderator, Anne Kruse, welcomed everyone at 11:12 a.m. and delivered an Opening Prayer for the 124th Annual Meeting, “Prayers for guidance and God’s will in this year of change.”
- Clerk, Kim Paré, confirmed a quorum (50 required) 62 in attendance.
- Approval of Minutes from last Congregational meeting on April 29, 2018. David Raphael made a motion to accept the minutes as written/presented. Stephanie Kissiday seconded. There were no questions and no discussion. The congregation voted and unanimously approved the motion. No abstentions.
- David Raphael made a motion to accept the Minutes from the January 27, 2019 Congregational Budget Meeting as corrected and amended (3 edits: 2names and a pronoun). Dennis Christo seconded. There were no questions and no discussion. The congregation voted and unanimously approved the motion. No abstentions.
- Team TLC (Sarah Blodgett, Nancy Cimato, Joanne Wilder, Raymond LeBlanc, Joyce Smith) presented and read GPC Bedrock Beliefs statement. The congregation applauded Team TLC’s efforts over the past year. David Raphael made a motion to affirm the Bedrock Beliefs statement as presented in the 124th Congregational Meeting. seconded. There were no questions and no discussion. The congregation voted and unanimously approved the motion. No abstentions.

- David Raphael made a motion to adopt the Restructuring Proposal and By-Laws revisions as written/presented. Marion McLaren seconded. There were no questions. Loyall Allen congratulated all involved in this process: Team TLC, Reverend Kevin Downer, Moderator Anne Kruse, and the By-Laws Team, for all their efforts in moving this work forward. The congregation voted and unanimously approved the motion. No abstentions.
- Moderator Anne Kruse that there are more opportunities to serve on the next Governing Board. The approval of the revised by-laws defines the transitional Governing Board.
- Russ Vickstrom presented the Annual Report. David Raphael made a motion to approve the 2018 Annual Report as written/presented. Marion McLaren seconded. In summary: the first quarter of 2019 shows income is 2% higher than projected, including collections, and 4% above budget; however, there were unplanned expenses – installing a commercial grade grease trap in the kitchen; and Food Hub paid their year’s rent in advance. Thus, there was a 7k difference in actual expenses (\$78, 008) from budgeted expenses (\$69,106). An investment withdrawal was voted by Council in January 2019 to bridge this difference and 20k was taken from the endowment, but Russ stated we’re essentially borrowing from ourselves. This time last year we had borrowed 70k to bridge the deficits in the budget. We only used 20k this year and already put 5k back in the endowment. To cut costs, GPC dropped the advertisement in the Telegram & Gazette, reduced staff health care/dental costs and administrative budget, and reduced IT support from Trailside Communications. The Governing Board will explore revenue opportunities at Selah as well as from hosting a Murder Mystery Dinner Theatre. Questions and discussion ensued. Dave Raphael stated that the new lighting in the chapel was sponsored by the Seale/Ekstrom family. Deb Richards asked, “Was there a final reconciliation with Apple Spice?” Russ stated that at the time of Kim’s departure, she owed GPC four month’s rent. Kenneth White asked if there was an audit. Russ stated, “No.” There was no further discussion. The congregation voted and unanimously approved the motion. No abstentions.
- Dave Raphael thanked Rev Kev for all of his efforts since ministering to GPC. Congregation gave Rev Kev a standing ovation. Rev Kev acknowledged that the work

being done is through prayerful, passionate, intentional processes. He said his contract has been extended through June 2020. The next phase/exploration is Vision. What do we need for a next pastor? What is God calling us to do, where to go? He applauded Team TLC for their work of heart, passion and committed participation. Rev Kev affirmed we are making ground as we walk it. The Council just voted themselves out of a job with the Governing Board transformation. Everyone can stay up to date via GPC's web page and in The Link.

- Dave Raphael made a motion to adjourn. Marion McLaren seconded. The congregation voted and unanimously approved the motion. No abstentions. The meeting was adjourned at 12:02 p.m.
